(No. 13 of 2019)

MALAŴI ENGINEERING INSTITUTION (REGISTRATION AND DISCIPLINE) REGULATIONS, 2021

IN EXERCISE of the powers conferred by section 65 of the Malaŵi Engineering Institution Act, 2019, I, NANCY CHAOLA MDOOKO, Deputy Minister of Transport and Public Works, on the recommendation of the Institution, make the following Regulations—

PART I—PRELIMINARY

Citation

1. These Regulations may be cited as the Malawi Engineering Institution (Registration and Discipline) Regulations, 2021.

PART II—REGISTRATION

Procedure for registration

- 2.—(1) An application for registration under the Act shall comply with these Regulations.
- (2) An applicant making an application for registration under the Act shall specify, in his application, the class of membership in which he seeks to be registered into.
- (3) The applicant shall complete and sign an appropriate form set out in the First Schedule hereto.
- (4) An application made under this regulation shall be submitted to the Registration Council through the Registrar, accompanied by an application fee as prescribed under Part I of the Second Schedule hereto.

Documents in support of application

- 3. An application for registration under the Act shall be supported by—
- (a) a statutory declaration made by the applicant in the form set out in the Third Schedule hereto;
- (b) certified copies of any degrees, postgraduate diplomas or certificates on which the applicant relies on as qualifications for registration;
- (c) in the case of an applicant for registration whose name has changed since the grant of his qualification, the legal document which provides evidence of such change of name; and
 - (d) a copy of the national identification document.

Acceptance or tration

- 4.—(1) The Registration Council shall, once it receives the application refusal of regis- form, review the application to ensure that it satisfies the minimum requirements of the class of membership to which it relates.
 - (2) In considering whether the applicant meets the minimum requirements, the Registration Council shall take into account the applicant's-
 - (a) physical or mental health;
 - (b) professional track record; and
 - (c) prior misconduct.

- (3) Where the application fails to meet the minimum requirements, the Registration Council shall inform the applicant of the failure of the application to meet the minimum requirements and the grounds therefor.
- (4) An applicant shall be afforded an opportunity to be heard in support of his application.
- (5) Where the Registration Council is satisfied that the application meets the minimum requirements in the class of membership applied for, it shall recommend to the Board that the applicant should take the relevant engineering qualifying examination within a specified period.
- (6) Where the applicant passes the examination referred to under subregulation (5), the Registration Council shall, upon approval of the Board, issue to the applicant a registration certificate in the form prescribed in the Fourth Schedule hereto:

Provided that any person qualifying for registration for the class of professional engineer and above, the person shall take an oath provided for at the back of the certificate before a commissioner for oaths.

- (7) Where the applicant fails the engineering qualifying examinations, the Registration Council shall advise the applicant accordingly and inform him of his right to take the examination one more time.
- (8) Where the applicant qualifies for registration into a particular class of membership, the applicant shall be entitled to use the description of that class of membership as prescribed in the *Fifth Schedule* hereto.
- 5.—(1) A person registered under the Act shall pay the fees prescribed Registration under Part II of the Second Schedule hereto for services listed under that Part. fees

- (2) A fee for registration under this Act shall not be refundable and shall be payable not later than 31st December of each year.
- (3) Where the fee for registration or any part thereof remains unpaid for more than thirty days after the due date, a penalty of fifty per cent of the amount due shall be imposed and shall become part of the amount due and payable.
- (4) There shall be no reduction, proportionate or otherwise, in the amount of the fee payable even if the remaining period to the next 31st December from the date of registration or from the date of payment of the amount due is less than twelve months.
- 6. The Registrar shall, soon after 1st January of each year, publish, in List of registhe Gazette, a copy of the register containing a list and categories of all persons registered under the Act, as prescribed in the Sixth Schedule hereto.

tered persons

7. Every person registered under this Act shall notify the Registrar of Notification any change in his business or correspondence address, as the case may be, within fourteen days of the change.

PART III — CODE OF CONDUCT

Primary obligations of persons registered under the Act

- 8. A person registered under this Act shall—
- (a) conduct himself in such a manner as to uphold the reputation of the profession;
- (b) discharge his duties with fairness and impartiality to the public, his employer and clients with efficiency, competence and confidentiality, without undue delay;
- (c) exercise care in the performance of his duties, including adherence to workplace safety obligations and responsibilities; and
- (d) not engage in conduct involving dishonesty, fraud, deceit, corruption or misrepresentation.

Competence and other considerations

9. A person registered under this Act shall—

- (a) only undertake work for the execution of which his training and experience have rendered him competent and employ only adequately qualified personnel as demanded by the task for which he is employed;
- (b) maintain, develop and employ appropriate levels of knowledge and skills for the task for which he is employed;
- (c) refrain from, either personally or through the agency of another person, whether or not such person is in his employment, making or offering to make by way of commission or otherwise, payment or other consideration for the obtaining of professional employment;
- (d) not misrepresent data or its relative significance in any report produced by the Institution;
- (e) not knowingly permit the publication or use of his data, reports, maps, or other professional documents for unlawful purposes;
- (f) only express professional opinions and make statements that have a basis in fact or experience or accepted principles and on the basis of adequate knowledge and when required to give evidence with fairness and honesty without prejudice or discrimination;
- (g) be fair and impartial in the provision of advice and judgement to an employer or any other party to an engineering assignment in which he is involved;
- (h) attribute proper credit to others for their professional work or professional contribution and not misappropriate the professional work of others;
- (i) not claim as his own, or suppress, work carried out and recommendations made by any other engineer nor alter work done by another engineer in such a way as to distort the latter's professional opinion;
- (j) not undertake any duties or carry out any instructions of an employer or supervisor which involve making statements purporting to be his own but which are contrary to his *bona fide* professional opinion, and not to instruct any other engineer to do so;

- (k) undertake to notify another engineer where, to his knowledge, the other engineer has prior appointment relating to any work he is being approached for possible appointment;
- (I) not act in a professional capacity for a public body without notifying, as a matter of courtesy, the most senior engineer or head of that public body;
- (m) be modest in scale and frequency, when advertising for his professional work as an engineer;
 - (n) not undercut when charging his clients; or
- (o) not, in undertaking his professional activities, discriminate on any ground.
- 10. A person registered under the Act shall build his reputation based on merit and shall refrain from any form of unfair competition, including—

Avoidance of unfair competition

- (a) use of a professional designation to which he has no entitlement;
- (b) the offer of inducements to secure work or advancement;
- (c) the undermining of another person registered under the Act with prior appointment relating to any work; or
 - (d) breach of the regulatory framework of engineering.
- 11.— (1) A person registered under the Act shall not—

Conflict of interest

- (a) hold, assume, accept or retain a position in which his interest is in conflict with his professional duty;
- (b) undertake paid professional work from any authority or organization of whose governing body he is a member;
- . (c) act in circumstances where there is a potential conflict between his own private interest and the interest of his client or public interest; or
- (d) undertake any work which gives rise to any conflict of interest between his clients, including public clients, unless otherwise agreed by the clients:

Provided that where a person registered under the Act is aware of a conflict or potential conflict of interest, he shall inform the client of the interest and obtain the consent of the client, in writing, to proceed.

- (2) A person registered under the Act who undertakes engineering work on behalf of a client shall not, until that engagement has been terminated, undertake work for, or on behalf of, any other client if by doing so the interests of either client would be in any way prejudiced or the ability of the engineer to act in the interests of either client would be in any way impaired.
- (3) A person registered under the Act may, only in exceptional circumstances, such as where the registered person alone possesses the required expertise, act where a potential conflict of interest exists or may arise and prior to accepting any such engagement, the person registered under the Act shall disclose the relevant details to the client or clients concerned.
- (4) A person registered under the Act shall disclose to his employer or client any gift, commission or discount he may have received from or offered

by a third party in connection with his professional work, and he shall not accept any such gift, commission or discount where their receipt may or may be perceived to, influence his advice.

Disclosure of confidential information permitted in some circumstances

- 12.—(1) A person registered under the Act shall treat all information of a client as confidential.
- (2) A person registered under the Act has the duty to ensure that no person misuses information of a client.
- (3) A person registered under the Act shall not use, for his own benefit, information of a client.
- (4) A person registered under the Act may disclose otherwise confidential information belonging to a client in order to comply with the law including-
 - (a) where required to do so by a competent court of law;
 - (b) a meeting of an engineering committee or a meeting under the Act; or
 - (c) where required to do so in accordance with a provision of any written law.

PART IV—DISCIPLINE

Inquiry into misconduct

13.—(1) Subject to section 49 of the Act, the Disciplinary Committee shall inquire into any act or omission amounting to professional misconduct of a registered person:

Provided that the Disciplinary Committee may, on its own, inquire into an act or omission amounting to professional misconduct.

- (2) The Disciplinary Committee shall finalize the inquiry under subregulation (1) within sixty days.
- (3) The Institution, on the recommendation of the Disciplinary Committee, may, if the Disciplinary Committee finds a person guilty of misconduct, mete out a sanction as provided under section 52 (4) of the Act.

Application to istered under the Act

14. Every person registered under the Act shall be subject to the all persons reg-jurisdiction of the Disciplinary Committee on matters of discipline.

Powers of Disciplinary Committee

- In addition to the powers under section 48 of the Act, the Disciplinary Committee shall have the power to-
 - (a) receive complaints referred to it, as the case may be;
 - (b) investigate all complaints brought before it;
 - (c) conduct hearings on disciplinary matters; and
 - (d) recommend, to the Institution, the imposition of any penalty specified under section 52 (4) of the Act.

Minutes of meetings of Disciplinary Committee

The Disciplinary Committee shall keep the minutes of all its 16. meetings.

17.—(1) A person appointed to the Disciplinary Committee shall hold Tenure and office for a period of three years, unless he-

vacancy for Disciplinary Committee

- (a) sooner resigns;
- (b) is removed from office; or
- (c) ceases to have the qualification necessary as a prerequisite to appointment.
- (2) A member of the Disciplinary Committee may be removed from office on grounds of-
 - (a) physical or mental incapacity;
 - (b) misconduct;
 - (c) bankruptcy;
 - (d) absence, without valid excuse, from two consecutive meetings of the Disciplinary Committee of which he has had notice; or
 - (e) conviction for an offence punishable with a term of imprisonment without an option of a fine.
- In case of a vacancy in the membership of the Disciplinary Committee, the vacancy shall, where the vacancy is occasioned by a person elected by the Institution, be filled by a person elected by the Institution to replace him, until the expiry of the period from the date of appointment of the Disciplinary Committee:

Provided that if the remaining period is less than six months, the vacancy may not be filled until the expiry of the period.

18.—(1) Subject to section 48 of the Act, the Disciplinary Committee shall regulate its own procedure.

Proceedings of Disciplinary Committee

- (2) The Disciplinary Committee may make rules for regulating the making, hearing and determination of applications or complaints under this Part.
- The Disciplinary Committee shall meet for the transaction of business at a time and at a place determined by the chairperson.
- (4) At any meeting of the Disciplinary Committee, members shall, in the absence of the chairperson, elect one of their number, to act as chairperson.
- 19.—(1) The Disciplinary Committee shall dispose of any matter before Time limits it within ninety days.

- (2) The Disciplinary Committee may, upon giving good and justifiable reasons, extend the period for disposing of any matter for a period not exceeding thirty days.
- (3) The Disciplinary Committee shall, upon reaching a decision on a matter before it, inform the complainant of its decision within seven days of the decision.
- (4) Where the Disciplinary Committee fails to dispose of a complaint within the time limit specified under this section, a complainant may refer the matter to the president of the Institution.

Publication of names of de-registered or suspended persons 20. The Institution shall publish, in the *Gazette* and in at least two newspapers with the widest circulation, names of persons registered under the Act whose names have been removed from the Register or have been suspended and, in the case of suspension, the period of suspension.

Rc-registration

- 21.—(1) A person registered under the Act whose name is removed from the Register may, after the expiry of five years, apply to the Council for re-registration to practice.
 - (2) On receipt of an application for re-registration, the Council may—
 - (a) re-admit the applicant;
 - (b) refuse to re-admit the applicant; or
 - (c) order that the applicant shall not be re-admitted unless the applicant—
 - (i) enrolls at the Institution and successfully passes the examination for the category of engineering he intends to practice under;
 - (ii) is supervised by an engineer of not less than ten years standing for a period not exceeding one year; or
 - (iii) restitutes any money or property, which is the subject of the de-registration.

Disclosure of interest

- 22.—(1) If a member of the Disciplinary Committee established under this Part is present at a meeting of a committee at which any matter which is the subject of consideration is a matter in which the member or his immediate family member or his professional or business partner is directly or indirectly interested in a private or professional capacity, he shall, as soon as is practicable, after the commencement of the meeting, disclose his interest.
- (2) Unless the Disciplinary Committee otherwise directs, the member referred to in subsection (1), shall not take part in any consideration or discussion of, or vote on, any question touching on the matter
- (3) A disclosure of interest shall be recorded in the minutes of the meeting at which it is made.

Evidence

- 23.—(1) A person who—
 - (a) is summoned before the Disciplinary Committee under this Part, and
 - (i) refuses or fails, without justifiable cause, to attend and give evidence relevant to the inquiry at the time and place stated in the summons;
 - (ii) refuses to be sworn or affirmed; or
 - (iii) refuses or fails, without justifiable cause, to produce any book,

record, document or thing which he is requested in the summons or otherwise to produce; or

The Registrar

(b) appears before the Disciplinary Committee and refuses to answer or to answer fully or satisfactorily to the best of his knowledge and belief any question lawfully put to him,

commits an offence and shall, upon conviction, be liable to a fine of one million Kwacha and imprisonment for six months.

(2) Any person who, at an inquiry under this Part, gives false evidence on oath, knowing his evidence to be false or not knowing or believing it to be true, commits an offence termed perjury and shall, upon conviction, be liable Cap. 7:01 to the relevant penalties provided under the penal code.

24. A person registered under the Act against whom a complaint is made Right to legal and has been brought before the Disciplinary Committee shall be entitled to legal representation and to bring a witness to any hearing.

25. A member of the Disciplinary Committee shall, on appointment, Oath of secretake an oath of secrecy as prescribed in the Seventh Schedule hereto.

26. A member of the Disciplinary Committee shall be paid allowances Allowances as determined by the Institution.

- (a) in Malaŵi, must be made under the Oaths, Affirmations and Declarations Act (Cap. 4:07);
- (b) in any other country of the Commonwealth, must be made before a Notary Public, Commissioner for Oaths or other person having authority in that country under any law for the time being in force to take or receive an oath, an affirmation or a declaration; and

(c) in any other place, must be made before a Malaŵian consul or vice-consul or before any person having authority under any Act of Parliament of the Laws of Malaŵi for the time being in force to take or receive an oath, affirmation or a declaration.
